## ENTRY FEES:

**Pre-Registration** (must be received at Muskogee Art Guild, Inc. **no later than March 15.**

Member - \$15 per item

Non-Member - \$20 per item

**LATE – at the door registration on March 29<sup>th</sup>.**

Members; \$20 per item/ Non-member \$25 per item.

## Prizes:

Best of Show - \$200

1<sup>st</sup> Place \$125 – each category\*

2<sup>nd</sup> Place \$ 75 – each category\*

3<sup>rd</sup> Place \$50 – each category\*

(\*Jewelry is a new category and will only have a cash 1<sup>st</sup> prize with ribbons for 2<sup>nd</sup> and 3<sup>rd</sup>.)

## TERMS AND CONDITIONS

**Deliver art to Arrowhead Mall** on March 29<sup>th</sup> between 10 am and 6 pm. Pick up art at the Mall on April 7 between 5 pm and 8 pm. Artists or their representative is responsible for delivery and pick up.

**Meet the Artist Reception** Saturday, April 7 – 2 pm to 5 pm. Artists are encouraged to attend and invite their fiends and family.

## Categories:

**I** Oil or Acrylic on canvas, canvas board, masonite or wood.

**II** Watercolor or Acrylic on paper

**III** Drawing – pastels, charcoal, pencil, pen and ink, monoprints, etc.

**IV** Mixed Media – Wall art that utilizes more than one medium or material.

**V** Photography – digital or film photography minimally altered through technology using standard darkroom techniques (like cropping, dodging and burning, etc.) and traditional photographic techniques.

**VI** 3-Dimensional – Free standing art.

**VII** – Jewelry – (see prize information)

- Entries must fit one of the categories listed above or will be rejected. Show committee reserves the right to re-assign category as needed.

- Open to all artists 18 years and older.

- Entry fees are non-refundable unless Muskogee Art Guild, Inc. cancels or changes the date of the show.

- All entries must be family appropriate (at discretion of the Exhibit Chair)

- All artwork must be original to the artist. (No workshop pieces will be accepted)

- Entries may not have won a monetary award from a previous Muskogee Art Guild show.

- All hanging artwork must be properly framed and matted (where applicable) and wired with sufficient strength wire for the weight of the art. Use standard backing and wiring.

- NO saw-tooth hangers, spring clasps, clips, uniframe, self-adhesive hooks, strings, cardboard hangers or brackets.

- NO exposed edge of glass or plexi-glass.

- Gallery canvass, properly painted and wired will be accepted without frames.

- When art is delivered to the show, and before acceptance, it will be inspected to determine if it is properly framed and wired. Opportunity will be allowed to make the necessary corrections or it will be disqualified from the show.

- While all possible care will be taken, neither Muskogee Art Guild, Inc. nor Arrowhead Mall are responsible for any loss or damage to art from the time it is accepted until it is pick up.

- Artist's name, title of art, medium and price should be placed on the back of the art by the artist.

- All art must remain on display until 5 pm April 7.

- Photographs of the art and artists may be used in publicity or record of the show.

- Muskogee Art Guild, Inc. is required to collect sales tax on all sales at the show.

- Members of Muskogee Art Guild, Inc. entering the show must arrange to host the show for at least 3 hours or arrange for someone to do so in their place. Non-members are encouraged to do so.

- In order to receive the member rate, dues must be paid on or before March 15, 2012.
